Lambeth Country Show 2022

If your application is accepted and you are invited to perform at the Lambeth Country Show, a contract will be offered to include the following:

- 1. The Artiste/s at the time of signing this contract warrants that they shall not be under any contract to a third party that might preclude him/her from fulfilling the engagement.
- 2. Non fulfilment of contract will result in loss or expenses incurred to be charged to the Artistes/Agent.
- 3. The Artiste's agrees that the fee is inclusive of all agreed expenses, travelling expenses to and from the venue unless otherwise agreed in advance and detailed on this booking agreement.
- 4. Once the artiste/s confirm the contract, the following fees will be applicable upon cancellation:
 - More than 30 days prior to the performance date; No fee payable to London Borough of Lambeth.
 - Between 22-30 days prior to the performance date; 25% of the full agreed fee to London Borough of Lambeth.
 - Between 15-21 days prior to the performance date; 50% of the full agreed fee to London Borough of Lambeth.
 - Between 8-14 days prior to the performance date; 75% of the full agreed fee to London Borough of Lambeth.
 - Between 1-7 days prior to the performance date; the full agreed fee will be payable to London Borough of Lambeth.
- 5. No fee shall be payable to the Artiste/s for any day upon which this engagement shall be suspended by reason of Royal Demise, National Mourning, Fire, Epidemic, War, Strikes, lockout or by reason of order of any Licensing or Authority and for any other reason outside of the direct control of the Council.
- 6. No fee shall be payable to the artiste/s in advance of his/her performance.
- 7. Artiste/s warrant that their performance does not infringe a third parties copyright or intellectual property and shall indemnify the Council against all costs associated with a third party threatening or taking any action in respect to such infringements
- 8. Artiste/s are responsible for their own tax & National Insurance contributions.
- 9. Artiste/s warrant that their performance shall not be contrary to any statute or other law and in particular any law in respect of health and safety
- 10. Artiste/s warrant that any performance or associated published material shall not lead to the defamation of a person or corporation and that he/she shall indemnify the Council against all costs associated with such threatened action or action.
- 11. Artiste/s warrant that any performance shall not be contrary to the Council's Equal Opportunities Policy, London Borough of Lambeth's Equal Opportunities Statement and shall not outrage public opinion.
- 12. The London Borough of Lambeth will make payment by BACS within 30 working days of Lambeth Country Show, as per London Borough of Lambeth payment policy.
- 13. Artiste/s understand that the land/buildings at which he/she provides his/her performance is licensed to him/her for the provision of the performance only and shall not at any time during the provision of the performance or at any time thereafter claim or seek to enforce any lien, charge, or other encumbrances over property of whatever nature owned by the Council and which is for the time being in the possession of the Artiste/s, for the purposes of this agreement.
- 14. No drink/food/alcohol, except water, to be consumed during performance on stages/platforms unless you have been given authorisation by members of the event team. Food and drink may be consumed during performance breaks.
- 15. Artiste/s who are required to leave the show site before show close must have vehicles parked off the show site in order to do so. No vehicle movement is permitted during show opening hours.
- 16. Artiste/s warrant that they have full capacity to enter into this agreement.
- 17. Artiste/s shall indemnify the Council against all costs arising from a breach of this agreement by him her whether criminal or civil for whatsoever reason.
- 18. Artiste/s agrees to the Terms and Conditions set out above up signing of the contract.
